NCTRC Email Notification Application -Policy and Application-

Individuals/organizations may request that NCTRC distribute information directly related to continuing education opportunities, professional practice issues, informal research surveys, or important developments that directly affect the CTRS professional and TR/RT Practice. The request for distribution of materials related to formal research projects or academic thesis studies must be submitted via the *NCTRC Research Contact Application*. This policy outline and attached application provide the necessary information and procedures required to initiate the request for an email distribution of materials.

Note: NCTRC does not distribute generic information from commercial vendors.

Procedures:

1. The email distribution available for purchase includes only CTRS certificants who have consented to the release of their contact information.
2. The application and signed agreement should be received by NCTRC at least thirty (30) days before the actual date of the expected email distribution.
3. NCTRC does not release the actual email addresses of CTRSs. Rather, NCTRC distributes an email message to CTRSs containing a link to the host provider's website. The email distribution sent via the NCTRC system will include the following statement from NCTRC:
NCTRC has been requested by (name of requestor/organization) to provide you with the following link: (insert link)
4. The organization requesting the email distribution must be a recognized CE provider, or therapeutic recreation professional organization at the national, regional, state or local level.
5. Unless noted in the continuing education document, NCTRC has not reviewed or approved the content of these materials, and does not endorse or sponsor any of the activities of this organization.
6. The application will not be processed unless all required website links and appropriate fees are received by NCTRC along with the signed Licensing Agreement. Please note that NCTRC shall maintain final approval of all requests for the email distribution and reserves the right to withhold distribution of material to protect the interests of NCTRC and/or NCTRC's certificants. Please allow up to four (4) weeks for the application to be processed.
