National Council for Therapeutic Recreation Certification® (NCTRC) offers both need-based and merit-based programs to support the therapeutic recreation profession.

The **NCTRC Scholarship Program** is designed to recognize the achievements of those who seek to advance their knowledge and professional competency to improve the quality of recreational therapy services.

Since NCTRC believes that the fees associated with the certification application process should not be a deterrent to furthering your career, the **NCTRC Hardship Fee Waiver Program** was created to support applicants and certificants.

NCTRC SCHOLARSHIP

Individuals may apply for an NCTRC Scholarship for full or partial reimbursement of funds associated with successful completion (earned grade of B or better) of academic credit-generating course(s) completed within the past 12 months. Academic courses must lead to an application for Professional Eligibility, recertification of the individual's CTRS credential, Specialization Area Designation, progress toward advancement of a degree in TR/RT, or enhanced recreational therapy knowledge to provide improved quality of care.

SUBMISSION PROCESS:

- Complete the Scholarship Application, found via the QR code below.
- Scan all materials into one PDF document that will become your application submission packet. Email the PDF application packet to nctrc@nctrc.org and include "Scholarship" and your full name in the subject line.

NCTRC HARDSHIP WAIVER FEE

This program waives fees associated with applying for or maintaining the Certified Therapeutic Recreation Specialist® (CTRS) credential, and is open to certificants, past certificants, and future certificants who qualify.

SUBMISSION PROCESS:

- The applicant calls NCTRC at 845-639-1439 and speaks with a credentialing specialist.
- After the phone call, NCTRC staff will email the caller a copy of the Hardship Fee Waiver form and application(s) for the fees they wish to have waived.
- Email your completed application and your supporting documents to nctrc@nctrc.org and in the subject line note "Fee Waiver Request".
